

## **The European Union Review publishing ethics (inspired by the COPE Best Practice Guidelines for Journal Editors).**

The editor promotes the publication of high-quality research works that can contribute to the progress of the European integration process by fuelling a robust and constructive discussion on principles and models to be pursued and applied.

To this end the editor ensures the application of the principles of independence, confidentiality and fairness in the application of a double-blind refereeing process. Unbiased review is also ensured in case of submissions from the members of the editorial board.

Referees are asked to examine the submitted paper objectively and confidentially, helping authors to improve their papers and their research approaches.

The editor, the editorial board and reviewers will not disclose unpublished information about a submitted manuscript, nor use it for their own benefit.

Authors who submit articles agree to the following terms of conduct regarding avoidance of plagiarism, authorship, redundant publications, copyright protection, legality and disclosure of conflicts of interest.

The paper is the authors' original work, the contents are based on the authors' own research and are expressed in their own words. If authors have used the work or words of others, they must be appropriately cited and referenced.

All individuals identified as authors actually contributed to the paper, and all individuals who contributed are included. Those who have provided support but have not contributed to the research should be acknowledged on the first page of the article.

If the paper was prepared jointly, the corresponding author has informed the co-authors of the terms of conduct and has obtained their signed written permission to adhere to and to sign the Licence for Publishing on their behalf as their agent.

The paper submitted are original new research, not yet published and not under consideration or accepted for publication elsewhere.

If excerpts from copyrighted works owned by third parties are included, the authors shall obtain written permission from the copyright owners for all uses, and show credit to the sources in the paper.

The paper and any submitted supporting information must contain no libellous or unlawful statements, must not infringe upon the rights (including without limitation the copyright, patent or trademark rights) or the privacy of others, must not breach any confidentiality obligation, must not violate a contract or any law, must not contain material or instructions that might cause harm or injury, and must only use data that has been obtained in accordance with applicable legal requirements and the journal's policies.

The author must confirm that there are no conflicts of interest relating to the paper, except as disclosed. In this case, the following information shall be clearly identified on the title page of the paper: (1) all financial and material support for the research and work; (2) any financial interests the author or any co-authors may have in companies or other entities that have an interest in the

information in the paper or any submitted supporting information (e.g. grants, advisory boards, employment, consultancies, contracts, honoraria, royalties, expert testimony, partnerships or stock ownership); and (3) indication of no such financial interests if appropriate.

After publication, in case of detection, the author is obliged to provide retractions or correction of mistakes, as well as clarifications and apologies when needed. The publisher and the editors will always be willing to publish the necessary corrections and explanations.

In relevant cases, published papers can be retracted, replaced or removed. The original version will be kept in the official archive.

Papers will be retracted when there is a violation of professional ethics (e.g. multiple submissions, plagiarism, false claims of authorship, counterfeit data). A retraction note, signed by the editors, will be published in a journal's issue and included in the summary. The same retraction note will be displayed at the beginning of the article.

The paper replacement takes place if the content could pose a severe risk when implemented. In this case, after an investigation, the authors will be asked to replace the original with an amended version. A replacement note will be published in the journal.

Papers will be removed if there is a violation of legal rights (e.g. defamatory content). In this case, the original document cannot be retrieved any more for legal reasons.
